

## NOTICE OF MEETING


### FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 151

The Board of Directors of Fort Bend County Municipal Utility District No. 151 will hold a regular meeting on Monday, June 26, 2023, at 12:00 p.m., at the offices of Inframark LLC, 2002 West Grand Parkway North, Suite 100, Katy, TX 77449, to discuss and, if appropriate, act upon the following items:

1. Comments from the public.
2. CONSENT AGENDA: The following items are considered routine by the Board and will be enacted by one motion. No separate discussion will occur on these items unless a Board member so requests, in which event, the item will be removed and placed on the Non-Consent Agenda.
  - a. approve minutes;
  - b. financial and bookkeeping matters, including payment of bills, budget comparison, and review of investments;
  - c. tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills;
  - d. authorize delinquent tax attorney to proceed with collection of delinquent taxes;
  - e. maintenance and mowing of District facilities, environmental monitoring of facilities, fees for violation, and hearing and opportunity for appeal for withholding tap service for nonpayment of backcharges;
  - f. report on lake maintenance; and
  - g. fire protection services matters, including maintenance of fire station.

4. Additional financial and bookkeeping matters.
5. Adopt Resolution Nominating Candidate for Board of Director Election for Fort Bend Central Appraisal District.
6. Review Renewal Amendment to Agreement for Automatic Aid Assistance with the City of Katy for fire protection services for the District and authorize appropriate action, if necessary.
7. Garbage collection and recycling services.
8. Engineering matters, including preparation and approval of plans and specifications, advertisement for bids, bid review, contract award, pay estimates and change orders, acceptance of projects, as appropriate, for the following:
  - a. Texas Department of Transportation sound wall and FM 1463 road widening project;
  - b. wastewater treatment plant improvement project;
  - c. water plant improvement project;
  - d. sidewalk and pedestrian mobility improvement project;
  - e. Tamarron Crossing waterline relocation project;

  - g. reclaimed water system;
  - h. Lift Stations No. 1 Improvement project;
  - i. South Firethorne Road crosswalks;
  - j. Annual Water Plant Inspection;
  - k. Lead and Copper Rule Revision; and
  - l. deeds, related environmental proposals, easements, encroachment agreements, right of entry agreements, conflicts waivers, and requests for service or utility commitments.
9. TCEQ Phase II Small MS4 General Permit matters, including status of compliance, necessary training, and public comment.
  10. Park and landscape maintenance matters, including:
    - a. proposals for additional work;
    - b. resident or Firethorne Community Association requests; and
    - c. review services agreement with Terry's Landscaping.
  11. Park and landscaping development matters.
  12. Operation of District facilities, including billings, repairs, maintenance, and backcharges, and customer correspondence and appeals.
  13. Hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
